Speaker::

Greg Upham was our speaker this morning via ZOOM. He wasn't able to be at breakfast in person as he is enjoying his 15 month old granddaughter's company.

Greg spoke mainly about the re-opening of the school system on August 24th. Out of 17,600 K-12 students enrolled, it was estimated that approximately 30% or roughly 5000 students would be disengaged from school, so it is of utmost importance to again start live classroom learning, observing CDC guidelines.

As the COVID cases expanded in Yellowstone County in July, Greg received more and more emails concerning remote learning via computer.

One thing for sure about the virus Greg said, is "We know that no one REALLY knows". The Covid-19 virus changes the re-opening plan on a daily basis.

As of yesterday, 900 students out of the 17,600 enrolled are learning remotely... well below the 5000 originally estimated to be disengaged from the school system.

Everyone is very concerned about the uptick in child abuse cases. There has been a massive increase in backpack meals being prepared and distributed to students.

High school students were given the opportunity to attend a summer program from June 1 - July 31. 245 students took advantage of this program... they were required to be masked and temperatures were taken as they entered the building.

A reading program for 1st and 2nd graders was instituted to see if these students were able to be masked during live classes Face shields were worn by the teachers to enable them to see the students' enunciation. After 2 weeks of live classroom learning, Greg, along with the principal at Newman Elementary, analyzed this classroom learning situation and determined that the 1st and 2nd grade students were much further behind in their learning than originally thought, making it mandatory to reopen the schools.
