## **Program: Steve Simonson, Midland Empire Land Trust**

Steve Simonson, Government Affairs Director for Billings Association of Realtors and more importantly, fellow Exchange member. Steve is a member of the Downtown and Westend Clubs. Steve came today to talk about the Midland Empire Land Trust. Here are some of the highlights:

This group is working on a land trust in the heights. The land is school trust (state) land. It is across from Castle Rock school. They believe they will be able to build 900-915 homes on the land. The homes will be starter homes for folks in the 80120% median income which is those with jobs such police officers, teachers, fire fighters, etc. It is not low income housing.

As a parent of two kids searching for a house to buy, I can attest to the lack of properties available to buy in this range. It's even tougher for my clients in the low income housing range:(

The households would own the home but not the land. There will be a 75 year land lease. There will be an equity cap put into place. Around the 3% annually mark. This protects future affordability. This model

will help to keep the housing costs down. Typically, a mortgage payment shouldn't be more then 30% of gross income. When it's over that, they are considered house burdened. I prefer the term house

They are looking into other options get the cost down such as 3-D printing. This is quite an undertaking!
