Program: Penny Ronning, Human Trafficking Task Force

Penny Ronning was our speaker this morning. She started out by recognizing our member, Dr. Brad Kimball. She had frequent migraines but kept being told there was nothing wrong. After vision problems she went to the optometrist and Dr. Kimball believed she had a brain tumor and sent her for an MRI which confirmed she did indeed.

Penny is a born and raised Billings girl. Her father had the Happy Diner for many years. Penny became a CASA Advocate in 2016. Her first kiddo was a victim of sex trafficking. Realizing this was a problem in our community, she went to the FIB to get the task force going. It now has over 800 members. Human trafficking is a relatively new phrase even though it has been going on for many years. Human trafficking became a federal crime in 2000.

There are three committees within the task force; prosecution and law enforcement, protection and victim services, prevention and community awareness.

Prior to the task force, convictions were very rare. Since the task force began there have been 12 federal convictions and 26 state convictions.

They are training the community on the signs to look for. One training is for realtors to know the signs of trafficking going on in a house such as bars on the inside of the windows and padlocks on the outside of

doors. Code Enforcement is now reporting no illicit massage businesses.
