Terri Todd with Gratitude in Action as our guest speaker this morning. She and her husband founded GIA in 2016 while setting up their first "sober living home". Their mission is dedicated to fostering recovery and sober living, providing individuals a chance to achieve self-sufficiency.

One of the main reasons for this program is to try and alleviate the cost of resources on our community for individuals that are continually entering into incarceration and being passed off into programs. Tax dollars can range from 29k-100k per individual depending on how many times they have gone through the process.

In 2019 GIA opened a thrift store in the old Salvation Army facility. When they have surplus that they don't use, they ship it overseas. Terri has actually spoken with a mission worker in Africa that was onsite when one of their bundles showed up in a community.

Terri spoke a little about the homeless problem downtown and what it costs the tax payers currently vs what permanent supportive housing would cost. The numbers were staggering.
