b. April BOD Meeting Minutes

II. Office Reports

a. Secretary's Report

Cory submitted Dina Harmon's report in her absence. Membership currently at 177. Ashley Harada payment was received 5/14.

We had one member, Kelsey Clark resign from club and five members transferred from our club to Westend Club: Randall Rice, Aubrey Kincaid, Doug Blehm, Tasha Straight, and Shelby Williams.

BEC will have eight members attending Nationals; Rene', Tony, Dina, Quentin, Leif, Stacy, David W. and Jerry Voto. I'm dropping our voter credentials card in the mail to National in the morning.

The deadline to apply for the majority of the National Awards is June 1, so I am working on getting a lot of award stuff done this month.

b. Treasurer's Report

Treasurer Ed Kaufman submitted financial reports to Board.

Ed starting budgeting process. Cory to send out email to Budget Committee to get them prepared Ed would like to present Budget in June to membership.

Ed will need to transfer money from money market account to cover granting.

There are several concerts in the new year, with a couple of possible concerts on calendar.

III. Committee Reports

a. Granting

Kevin Davis submitted granting recommendations. Granting recommendation was \$38,500, exceeding April's approved amount. John E motion, 2nd Don to increase grant funding to \$38,500. Motion carried unanimously.

b. Food Truck Wars

Rene Critelli updated the Board with progress. FTW meeting committee is 5/15. About a month out, 7k interests on Facebook with 26 Food Trucks signed up. Committee is working through required documents for Riverstone Health. Will be requesting certificates from the vendors.

Have not received much support for developing flag layout. FTW could use assistance on that from the Club.

IV. Old Business

a. ID Scanners

The Scanners were not shipped, so we could not use them for PBR. John Wilson visited with MTA & Bobbie Hunter if she could research use of ID Scanners by MTA members. No one contacted uses the ID Scanners. In further research, none of venues in region use them. Metrapark was asked about use of scanners, they have deferred that decision BEC, and there was a concern that any slowing of lines would be problematic. Motion Don, 2nd John W to discontinue trial of ID scanners by vendor for failure to perform.

b. Golf

Club received request for golf team at the Big Brothers Big Sisters tournament 6/15 1pm start. John W motion, 2nd Cory, motion to provide 1 team passed unanimously.

c. 40th Bash
