I. MEETING CALLED TO ORDER

The Fair is set to go on without night acts, however, there may be some small night shows. BEC will serve beer at the Fair from an outside tent - location TBA.

The Metra has been in touch with the DBA re: hosting Alive After 5 at MetraPark. BEC would serve beer.

Looking ahead:

Toby Keith is still on for Sept 17.

Team roping is scheduled - BEC will not serve beer, but will receive ¼ of the beer sale proceeds.

Nile is set for October.

A concert is scheduled at the Metra for October 24.

In This Moment has rescheduled for May 2021.

Luke Combs concert date TBA.

COVID Prepping

When operations and beer serving start back up, hand sanitizer, sanitizing wipes, gloves, and masks will be needed. Gloves and masks will be required to be worn by all BEC members working events. In regard to Brews and BBQs, it was suggested that the event organizers cover the cost for hand sanitizer, wipes, gloves, and masks for that event. Mike will look into that.

R-serving Renewal

It is an unwritten policy of BEC that members must renew their R-serving certificate within 30 days' prior to expiration. No formal policy will be established.

Liquor License Location

Tony set forth the idea of moving BEC's liquor license location to Par 3 Golf Course, either as a permanent location or until we have another permanent location. It was suggested that BEC may make arrangements to sell beer there on the weekends. It was agreed that Tony should discuss the matter with the manager of Par 3 and the City.

Steve is looking for direction on the Beijot Tourney scheduled to take place on July 31.
