## **II. OFFICER REPORTS**

#### Secretary's Report:

Secretary Shannon Johnson reported that the club's membership now stands at 131. Danielle Hughes resigned in February. Name badges were ordered on 3/1/2022 for all members in 2021 & 2022. # **Treasurer's Report:**

Treasurer Ed Kaufman was not present for the meeting, but he submitted notes via email and Wade Austin passed out the financials on his behalf. "Nothing of real note on the financials this month. The FTB committee sent out a check for \$7500.00 recently so of the \$33,397.23 balance in the general account approx. \$13,000 still belongs to the FTB fund and \$11,000 was not used by the Grants committee. Letters for those 3 should go out and perhaps a second one if we sent out letters to them last month."

#### **President Elect's Report:**

President Elect Cavin Nodding shared that we have two events left in March - Jeff Dunham on the

23nd and The Outlaws on 24th. A lot of people don't have to work anymore due to the distinguished member list. Getting tougher to staff, so still encourage people to take shifts to help out if possible.

## **Business Manager Report:**

Registration is \$275 per person, hotels are approx. \$500 for the 3 nights, and airfare is approx. \$700 to \$800 each. This was tabled for a motion until our next meeting so that we can learn who wants to attend.
