#### I. MEETING CALLED TO ORDER

#### II. OFFICER REPORTS

# **Secretary's Report:**

Secretary Shannon Johnson reported that the club's membership now stands at 124. One resignation for Danny Sandefur. Josh Henderson has applied to become a member of the club sponsored by Leif Welhaven. Two more members came in sponsored by Darryl Weber. All three of our new members are volunteering at Brews and BBQs and have already taken their R-serving! Great job! Everyone should take note for bringing in new members or presenting before the board, that the board now meets at the Legion on the second Tuesday of each month.

## **Treasurer's Report:**

-Ed reported that we are doing pretty well. He discussed that we have money to give to the grants committee so discussion was held to determine the amount of the funds. The board initially discussed giving \$45k, with 10% automatically going to the Foundation. So the Foundation will receive \$4,500k. Bruce Glennie made a motion for the \$45k with the automatic 10% to the Foundation. With further discussion, the board felt that \$50k was more appropriate so the 10% would be \$5k for the foundation. Bruce Glennie made an amended motion for the \$50k, and Tim seconded that amended motion. The motion passed unanimously.

-One thing worthy of noting, is that there is a check scam that happened and was discovered in time for the club not to lose money, so please everyone be diligent. If someone ever calls and tells you to cash something while they are on the phone with you, that's probably not legit.

-Ed went over the budget that was finalized by the budget committee. He inadvertently left off the National (\$5k) and District (\$2k) Convention funds, and has corrected those. A motion was made by Bruce Jensen, while Maria gave a second. The motion passed unanimously to pass the proposed budget.

## **President Elect's Report:**

Brews N BBQ, and reunion this weekend on July 16th. We still do not have near enough people serving for the second shifts from 4-7pm and 7-10pm. At this point we will accept anyone willing to come and help out. Wade is the new beer captain. Heights and Downtown have been contacted to see if anyone can help from their clubs. They may possibly need one more person. The fundraiser will be held on July 29th from 7-10pm. A live band will be playing. Bruce Glennie motioned that we participate as asked, and Wade gave it a second. The motion passed unanimously.

Bruce Jensen brought up the discussion about the lack of participation by the membership at large for the club. He suggested that a letter be written and distributed to the entire membership to remind folks what kind of a club we are and to reignite the reason everyone joined. To serve. Much discussion was held and many ideas were given to ensure that we no longer continue to face the challenge of not having people volunteer. This has become quite a source of frustration, especially for the position of the president elect who has to schedule each event and deal with no-shows, and cancellations from people not entering their availability on the website.
