Signage upgrades will need the approval of Metra Park, but they are willing to let us update the exterior of our booths. Craig also mentioned that better signage on the concourse at half house events would likely increase the traffic to our booth located in the Southeast corner.

CommUnity Rally (United Way) – Sept. 14 – beer pouring.

Mike Fleming and Craig Burke both agreed that we should serve this event again since we did it last year and it was a good community event. Like last year they will have a band and food trucks at the United Way location. Last year we served about (3) kegs of beer.
